They encouraged their peers to use the checklist, since everyone asking for similar info. in ISPs will help SCs to automatically include it.
- **New Day Service Rule Add-Ons** –new Day Services rules going into effect 4/1/17! Discussed add-ons and the need for teams to budget for services, and keep track of utilization so changes can be made before available funding runs out. Current Day Service caps are: A = \$10,595; B = \$19,045; C = \$31,720; Non-medical cap went up to \$10,042
