As COVID-19 vaccines rolled out in Ohio, LCBDD – and all of Ohio's 88 county boards – were charged by Governor Mike DeWine with assisting in the coordination of vaccines for people we support – and direct support professionals – who were eligible for vaccines under phases 1A and 1B and chose to receive them.

In Licking County, that meant our Provider Relations and Service Coordination departments came together to contact people we support, guardians and providers to schedule vaccine appointments.

Our website and social media pages reflected the latest information and our providers worked hard to make sure people they support had transportation.

Clinics at the Licking County Health Department and Licking Memorial Health Systems went smoothly, thanks to their employees, our caring community and our dedicated LCBDD staff.


