### • Old Business/Updates

- **Provider Relief Payments coming!** Payment will reflect 10% of claims submitted and paid for services delivered from 11/1/2020 through 10/31/2021. Services covered include HCP, Transportation, ADS & Voc. Hab, vocational services, shared living, and respite. Pending approval of submitted Appendix K by CMS.

### • New Business

- **New DSP training requirements-** taking a look at how DODD's requirements have changed, effective 1/1/22
  - Initial DSP training course
  - Annual DSP training course (approximately 2 hours)
    - Additional 6 hrs. of training
      - Agency can provide or can use DODD online optional training modules or can use other coursework (see attached email)
  - DSPs accessing their transcript or certificates on MyLearning
    - DSP transcript or certificates on MyLearning are transferrable from one agency to another – No need to re-train!
  - LCBDD's In-Person training – Teresa can also provide certificates for anyone who has taken her training as well by request
  - Don't let staff members share your log-in because certificate is non-transferrable
  - Have to complete modules in specific order as indicated on the website
    - Issue with online modules not showing as completed, but will be correct on the certificate
  - Course Catalogue > Providers
    - Currently experiencing issues with training files being too large to download for conducting in-person training
      - However, the online training is available and can be used for in-person training, but you have to watch the full videos
    - CDS indicated that powerpoint and videos have to be saved in same folder to work
  - Teresa Whipkey is available to provide in-person training
    - Contact Teresa to schedule a time for her to be a support person for them to complete the training
      - DSPs indicating most difficulty with the first two modules
