A message from our Superintendent Jason Umstot



At the end of September, leaders in Ohio's DD system gathered in Dublin for the ADVANCE Partnership Summit, which included teams from state agencies, county boards and providers.

During the three days of the summit, we were brought together to discuss the opportunities and challenges our system faces today.

Members of the Think Tank that helped organize the event were asked to present on a meaningful word that would inspire conversations.

My word was "inclusivity," which I found very fitting!

The Oxford English Dictionary defines inclusivity as "the practice or policy of providing equal access to opportunities and resources for people who might otherwise be excluded or

marginalized."

Merriam-Webster has a simpler definition: "The quality or state of being inclusive" - which means, "including everyone." Inclusivity is one of the founding ideas of Ohio's DD system. Families of people with developmental disabilities came together to create opportunities for their loved ones, so they could remain a part of their home communities. Over
